- Examinations for Professional courses for:
 - LLB, BCA, MCA, BBA, BSW and M. Pharm** will be held for all even Semesters commencing from 10th August, 2020 as already notified. (*remittance of fee by 6th Aug, 2020*)
 - B.Ed, M.Ed, B.Ed(Spl), B.Pharm, B.Sc(MLT), B.Optom, B.Sc (RIT), B.Sc(Nursing)** will be held for all even Semesters/year commencing from 17th August, 2020 as already notified. (*remittance of fee by 13th Aug, 2020*)
- Candidates are allowed to appear the examinations in Blended mode(online/offline), Student appearing **Online/offline** should answer the same set of Question Paper strictly as per the Examination Programme with the same duration. **Centre Superintendents** are delegated to conduct Online Exam(if any) and are responsible for fairness and accountability while conducting the exam. Centre Superintendent should immediately take the print out the answer script and submit along with the answer script of the Offline mode examination to Examinations Department.
- List of students** appearing in Online and Offline mode of examinations should be submitted to Examinations Department latest by 5th August, 2020
- Practical** examinations may also be allowed to conduct through Blended mode(online/offline).
- Continuous Assessment/Practical/Attendance:** The concern Institution will make arrangement to the shortfall in the wake of lockdown to enable student to appear the end semester/annual exam.
- External examiner** will not be appointed in Professional courses in Even Semester 2020, arrangement will be made by Principal/Director of the institution.
- Principal/Director** of the Institutions are requested to ensure that students leaving the state follow the normal procedure of Quarantine period before sitting in the Examination Hall. List of such student(s) if any may be provided to Examinations Department.
