1. Interested parties may submit bid for each vehicle individually in a sealed cover envelope latest by 12:00 noon 19.8.2020. The quotations and other relevant documents should be properly sealed. The envelope should be superscribed with **“QUOTATION FOR DISPOSAL OF CONDEMNED VEHICLES”**. The same should be opened at 2.00 PM on the same day.
2. Cost of quotation amounting to Rs 1000/- (non- refundable) is to be paid in the form of E- payment/ Online payment only to the following Account:
(i) Name of A/c holder : Director, RIPANS
(ii) Name of Bank : Bank of Baroda, Aizawl
(iii) Account No. : 30800100002790
(iv) IFS Code : BARB0AIZWAL (fifth character is zero). Cyber receipt / E receipt should be submitted along with the quotation.
3. The disposal of the vehicles shall be strictly on **“As is where is basis”** and no guarantee or certificate of its worthiness or its quality will be given by the Institute.
