## NOTIFICATION ON SECOND COUNSELLING FOR OUTSIDE NORTHEAST QUOTA

This is for information to all eligible candidates of Outside Northeast quota that Second online counselling for vacant undergraduate program seats (outside Northeast quota) will be held on **Sep 15, 2026, from 11 AM** onwards. The link for the online meeting will be provided by Sep 14, 2026, at 5 PM on the website.

- Candidates who have already been allotted a seat and have reported for classes may attend the counselling to opt for a change in their admitted program, subject to availability of seats, if any.
- Candidates who declined their admission offers in the first counselling may attend the second counselling and opt for admission to their preferred program, subject to seat availability.
- Candidates who were absent during the first counselling are NOT eligible to attend the second/subsequent round of counselling. However, a candidate (Sr. No. 13 in the eligibility list posted on the RIPANS website on Sep 02, 2026) who reported late during the first counselling due to a network issue shall be eligible for second counselling.
- Selected candidates from the first counselling who did not pay their fees within the stipulated time have been considered as candidates forfeiting their allotted seats, and such candidates shall NOT be eligible for second counselling.
- Selected candidates from the first round of counselling who did not pay their fees within the stipulated time have forfeited their allotted seats and shall NOT be eligible for the second round of counselling.
- Selected candidates who have paid the fees and have not reported for document verification and classes have forfeited their allotted seats and shall NOT be eligible for the second round of counselling.
- All the eligible candidates may attend online counselling; however, the candidates whose names appear within serial no 1 to 100 in the eligibility list (posted on the RIPANS website on Sep 02, 2026) will be called first for attendance and seat allotment according to their rank in NEET (UG)-2026. Further candidates may be called for attendance as well as counselling, subject to availability of vacant seats. They are advised to be available online till all the vacant seats are allotted.
- Selected candidates from the second counselling shall be required to complete the admission process by Sep 17, 2026, at 5 PM, and report for document verification as well as classes by Sep 21, 2026.
- Any seats remaining vacant after the second counselling will be surrendered to Northeast quota, and no further counselling will be conducted for outside Northeast seats.
