1. GENERAL RULES AND GUIDELINES:

The Director, Regional Institute of Paramedical Nursing Sciences (RIPANS), Aizawl, Mizoram invites request proposals for the "Interior Designing Consultancy for:-

- c) Remodelling of the Director's quarter at RIPANS, Aizawl.

From the registered Interior Designing Firm in accordance with the terms & conditions laid down by RIPANS.

2. OBJECTIVE AND NATURE OF THE SELECTION

- i. The objective of the Selection is to obtain most acceptable interior design proposal for the proposed work based on highest composite score (Technical & Financial) and enter into agreement with the selected firm for interior designing consultancy for the subject work.
- *ii.* This Selection will be in accordance with the guidelines mentioned herein.
- *iii.* Firms/Agencies participating in the competition must familiarize themselves with the site conditions mentioned in this document.
- iv. The Institute will not be responsible for non-receipt/late receipt of any communication sent by the participants due to postal delay/lost in transit.

- viii. The Concept Design, Technical and Financial proposals for the work shall be placed in two separate envelopes, and clearly marked (1) Concept Design/Technical Proposal and (2) Financial Proposal respectively. The envelopes shall thereafter be placed in one sealed envelope clearly marked as:-
 - "RFP for Interior Designing Consultancy for Renovation of Director's Office Chamber and Personal Branch at RIPANS, Aizawl"
 - "RFP for Renovation of Conference Hall at RIPANS, Aizawl".
 - "RFP for Renovation of the Director's quarter at RIPANS, Aizawl".

 With the name of the firms/agencies and contact details written thereof.

3. SCOPE OF WORK: The scope of work consists of:-

- a) To provide comprehensive interior design, drawings and detailed specifications.
- b) To give functional drawings of interior spaces in 2D and 3D Design drawings.
- c) To offer practical space.
- d) To ensure adequate air circulation, natural light entry, and door entrance.
- e) To provide great lighting creating depth and height, cosy spots, and drawing attention to the most impressive areas. So as to balance the light and shade and bring new energy to an interior.
- f) To conduct consultation and supervision work regularly so as to follow the design made from commencement to completion of the works.

- i. The firms/agencies are required to provide the concept design for the proposed renovation at the specified location.
- ii. The firms are free to explore various systems suited to the brief design.
- iii. The Concept Design proposal should demonstrate that the proposer has developed an understanding of the institute's requirements. The applicant shall submit an A4 Design proposal including the entire contents of the technical proposal for selection evaluation. The Concept Design proposal should be submitted in Envelope-I which should include the following:

- iv. Signed copy of RFP document and corrigendum/addendum, replies of Pre-bid queries, if any (Each page signed & stamped) by the firm as proof of acceptance of all terms and conditions of the selection process.
- v. A brief introduction about the firm, registration number and address of office in Aizawl.
- vi. Approach to design including drawings, sketches, diagrams and any other information that can concisely and yet comprehensively explain the applicant's concept psychology and design approach.
- vii. Experience details and work done.
- viii. The Concept Design Proposal shall be evaluated by the competent authority and the Financial proposal of only those technically qualified applicants shall be opened.
 - ix. The firm/agencies should have GST registration. Copy to be furnished along with tender documents.

5. ACCEPTANCE OF THE CONCEPT DESIGN:

The Concept Design as submitted by the successful applicant may not be deemed to be the final acceptable design proposal. The selected firm has to meet and discuss with the institute's authority and provide comprehensive services as per the scope of work after duly understanding the requirements of the Institute.

6. AWARD OF CONTRACT:

- i. The selection as mentioned above, does not, in any way, automatically confer any right, whatsoever, on any applicant for an award of work.
- ii. The selected firm, even though selected based on evaluation of his concept design shall be contractually obliged to modify or redesign if found necessary by the Institute.
- iii. The Institute will inform selected firm through a "Work Order"
- iv. The selected firm shall thereafter sign the contract agreement within 7 days of the issue of work order.
- v. The selected firm consultant willhave to deposit an amount equal to 5% of the offered and accepted value of the contract as a Performance Guarantee and deposit to the bank account mentioned below:
