**Common Criteria for admission (BMLS, B.Optom, B.MRIT, BPT & BND)**

1. He/she has completed 17 years of age at the time of admission or will complete that age on or before 31 December of the year of his/her admission to the first year of the Undergraduate Allied and Healthcare Course.
2. Reservation policy for admission in under graduate programs shall be as per the State/Centre Government norms.
3. Up to 10% seats shall be considered for lateral entry admission in Under Graduate program, wherever in respective program is permitted.
4. Medical fitness certificate is mandatory to submit and it is to be endorsed by Government medical officer.
5. The admission criteria shall be updated in accordance with the Commission directives from time to time.

**Note: The curriculum and admission criteria updated from time to time by the National Commission for Allied and Healthcare Professions (NCAHP) shall be adhered to for BMLS, B. Optometry, B.MRIT, BPT and Bachelor in Nutrition & Dietetics with Honours programs.**

As per Govt. of India rules.

**E) Selection Procedure :**

**North East States Quota:** The beneficiary 8 North Eastern States conducts entrance examination for the allotted seats. Candidates willing to take admission to the various programs conducted at RIPANS, Aizawl may contact their concerned state authority.

Candidate should not be allowed to change their course without approval of their State Government.

**Outside North East States Seats:** Seats reserved for outside NE States shall be filled by the Institute by inviting applications through inter-se merit on the basis of **NEET (UG) 2026 score**.

Any seat(s) remaining vacant from outside NE states quota and NE beneficiary states quota will be filled by the candidates from NE states through inter-se merit on the basis of **NEET (UG) 2026 score**.

- b) Reservation policy for admission in post graduate programs shall be as per the Centre Government norms.

***Note: The curriculum and admission criteria updated from time to time by the National Commission for Allied and Healthcare Professions (NCAHP) shall be adhered to for MMLS, M. MRIT and M. Optometry.***

**Note 1 :** During the course of study, if a student applies for a job (Government or Private) and subsequently in the event of his/her appointment and joining the same, his/her studentship stands cancelled. Further, the Security Deposit will also be forfeited.

**Note 2:** In service candidates should obtain “No Objection Certificate” and approval letter for study leave from the employer.

- c) **Note 3:** Candidates admitted to the Post Graduate are required to be registered as member of National Commission for Allied and Healthcare Professions (NCAHP).

**C) Reservation of seats:**

- (i) As per Government of India rules, the benefit of reservation shall be given only to those sections, which are listed in the central list published by the Government of India.
- (ii) Candidates belonging to OBC-NCL, SC, ST, General-Economically Weaker Section (General-EWS) and Person With Disability (PWD) categories will be given reservation

as per the Government of India rules i.e. OBC(NCL) - 27%, SC-15%, ST-7.5%, Economically Weaker Section (EWS)-10%. For Person with Disability (PWD) candidates, 5% seats shall be reserved on horizontal basis, subject to the condition that the candidate fulfills the other minimum eligibility requirements. Submission of a certificate to this effect issued by a competent authority/Board (details are given in this Brochure) shall be mandatory at the time of counselling. For the purpose of reservation under Economically Weaker Section (EWS) category, a person must comply with Government of India rules.

- (iii) In case the reserved seats remain vacant after counselling, the seats reserved for SC/ST/OBC may be inter changed and would be filled in. Even If the seats belonging to SC/ST/OBC category candidates remain vacant and the lists of both the SC/ST/OBC categories are exhausted, the remaining vacant seats shall be filled by the unreserved category (UR) candidates.

#### **Certificates Required for Reserved Categories**

- i) Scheduled Castes / Scheduled Tribes:** Each SC/ST candidate has to submit a self-attested copy of the Certificate issued by the Competent Authority mentioning that the candidate belongs to SC/ST category.
- ii) Other Backward Classes (OBC - NCL):** The candidates belonging to OBC-NCL category as listed by the Central Government must submit a self-attested copy of certificate issued by the competent authority. The OBC-NCL certificate should clearly mention that the candidate belongs to Non-Creamy Layer (NCL). The OBC-NCL candidate will be required to produce original income certificate having validity on the date of counselling. If no validity date is mentioned in the certificate, then it should have been issued in the financial year 2025-26.
- iii) Person With Disability (PWD):** Visually Impaired and/ or Hearing Impaired and/or Orthopedically Handicapped (on horizontal reservation basis) candidates, have to submit a self-attested copy of Disability Certificate issued by the District Chief Medical Officer/Medical Board. The disability benefits will be given to those candidates only who have at least 40% physical impairments. The percentage of disability should be mentioned in the certificate.

- iv) **General-Economically Weaker Section (General-EWS):** The benefit of reservation under EWS can be availed upon production of an Income and Asset Certificate issued by a Competent Authority.

## **F) Selection Procedure:**

- i) PG admission in Pharmacy shall be strictly based on valid GPAT score only. No Entrance Test for admission to PG Programs in Pharmacy shall be conducted by RIPANS.
- ii) For admission in M.Sc. Nursing, M.MLS, MMRIT and M. Optometry Programs,
  - Candidates who are found to be eligible will be called for Entrance Examination which will be held at RIPANS, Zembawak, Aizawl, Mizoram.
  - Question paper will consist of 100 questions of objective type with a single correct response out of four options. Each answer with correct response shall be awarded 1 (one) mark and there will be no negative marking. If more than one answer is indicated against a question, it will be deemed as incorrect response. The duration of the exam will be 2 hours.
  - Entrance examination Cut Off mark is 40%.

- Result of the Entrance Test in Order of Merit will be declared within 6 days of completion of the Entrance Examination and will be displayed on the Institute's website at [www.ripans.ac.in](http://www.ripans.ac.in). No correspondence regarding results will be issued to individual candidate.
- There will be no provision for rechecking/re-evaluation of answer sheets or communication of marks obtained at the entrance examination.
- Candidates will be called for counseling for admission in order of merit from the published result of the Entrance Examination. List of candidates called for counseling will be made available in the Institute's website.
- Candidates selected after counseling and Medical Examination shall have to pay the Admission fee/dues, etc. on the appointed date and get themselves admitted to the course, failing which his/her selection shall be treated as cancelled and seat will be offered to the next candidate on the waiting list in order of merit.
- Selected candidates who have been admitted but failed to join the course within a week after the commencement of the academic session shall automatically stand to forfeit their seat and no correspondence shall be entertained.

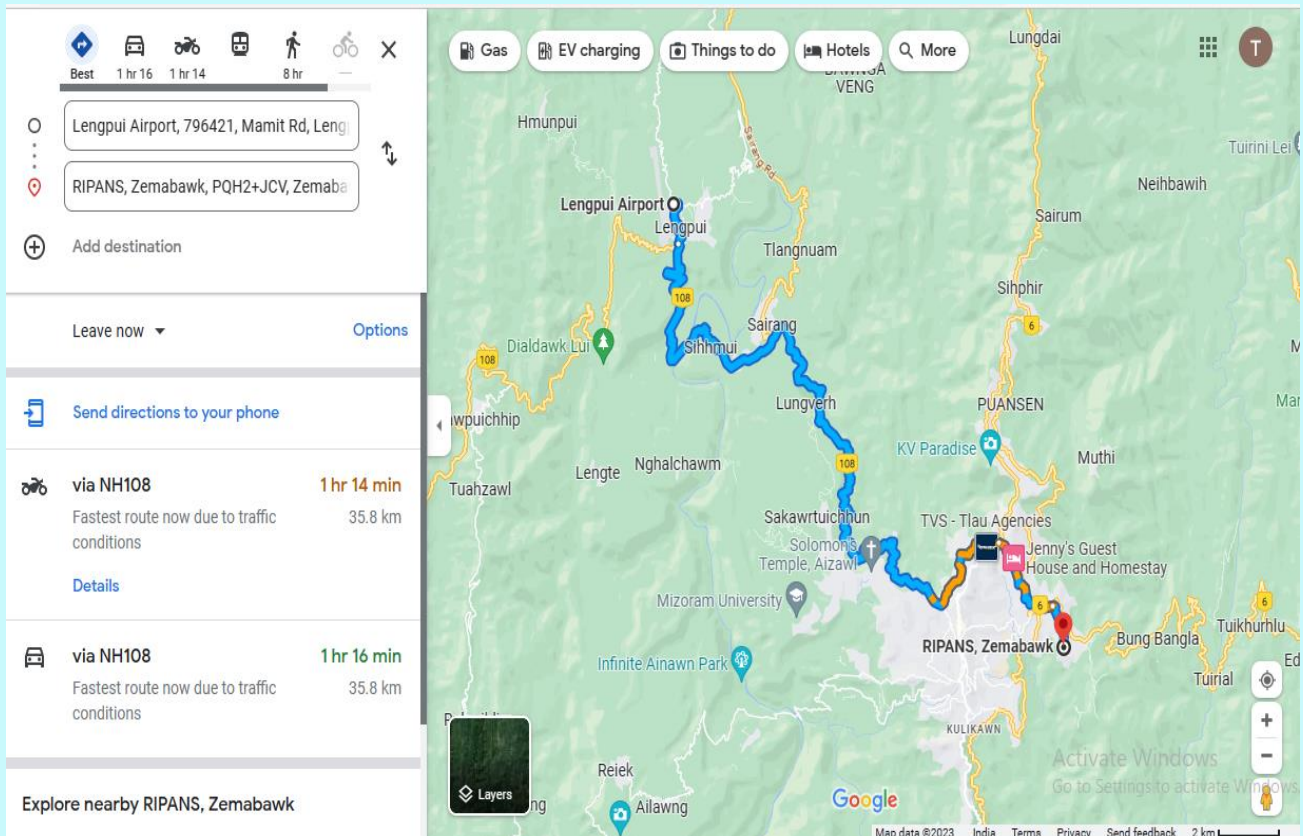

### PM-Vidyalaxmi Interest Subvention through Digital Rupee : Internal

- The Interest Subvention Processing will be done through Central Banks Digital Currency (CBDC).
